This matter having come to hearing on Plaintiff State of Ohio's prayer for statutory civil penalties against Defendant Demetrius "Duke" Ball ("Defendant Ball"), and the Court having heard arguments of the parties and being in all ways sufficiently advised:

IT IS HEREBY ORDERED that Defendant Ball:

1. Pay a civil penalty to the State of Ohio in an amount of \$7000.00, pursuant to R.C. 3704.06(C). Payment shall be made within 30 days to Ohio EPA, Office of Fiscal Administration, 50 West Town Street, Suite 700, Columbus, Ohio, 43215.
2. Any payment made after 30 days shall be subject to the statutory rate of interest under R.C. 5703.47, as authorized by R.C. 131.02.
3. Pay the costs of this action.
4. All payments shall be accompanied by a copy of this entry and/or a notation with the name "Demetrius Ball" and "Hamilton CCP Case No. A0706422."

The Court shall retain jurisdiction of this action for the purpose of enforcing and administering this Order.
