**RE: Franklin County Landfill, Franklin County
Explosive Gas Monitoring Plan Revision Approval**

Dear Mr. Flory:

On June 30, 2006, Ohio EPA, Division of Solid and Infectious Waste Management (DSIWM), Central District Office (CDO), received a revised document titled *Franklin County Sanitary Landfill Explosive Gas Monitoring Plan*. The original explosive gas monitoring plan (EGMP) was approved in 1996. This revised EGMP was submitted by Civil & Environmental Consultants, Inc., on behalf of the Solid Waste Authority of Central Ohio (SWACO). Comments on this revision were sent to SWACO on November 6, 2006. Ohio EPA received an amendment to the plan, from NTH Consultants, addressing these comments on April 25, 2007.

Ohio EPA has reviewed the revised EGMP as amended, dated April 25, 2007, and we have determined that it meets applicable requirements. Therefore, I hereby approve the April 25, 2007, EGMP for the Franklin County Sanitary Landfill. The owner shall implement this plan upon receipt of this letter.

Issuance of this approval does not constitute expressed or implied agreement that the monitoring of the facility, if performed and implemented in accordance with the approved explosive gas monitoring plan and/or its terms and conditions, will constitute compliance with all applicable state and federal laws, rules, and regulations.

You are hereby notified that this action of the Director is final and may be appealed to the Environmental Review Appeals Commission pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. The appeal must

be accompanied by a filing fee of \$70.00 which the Commission, in its discretion, may reduce if by affidavit you demonstrate that payment of the full amount of the fee would cause extreme hardship. Notice of the filing of the appeal shall be filed with the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section.
