**Re: East Liverpool Landfill, Columbiana County
Ohio Administrative Code (OAC) Rule 3745-27-09(C) Approval**

Dear Mr. Haaf:

On April 11, 2008, the Ohio Environmental Protection Agency (Ohio EPA), Northeast District Office (NEDO), Division of Solid and Infectious Waste Management (DSIWM) received a request to store your Operating Record for the East Liverpool Landfill (Facility) at an alternative location to the Facility. Specifically, you asked that you be authorized to relocate the Operating Record to your offices located at the Akron Regional Landfill, Inc. (ARLI), aka Hardy Road Landfill, located at 1585 Hardy Road, Akron, Ohio.

OAC Rule 3745-27-09(C) states, in part, that the operating record must be located at the sanitary landfill facility to be available for inspection by Ohio EPA and the approved health department during normal business hours. However, the director may approve an alternative location for the operating record upon commencement of the post-closure care period.

Pursuant to OAC Rule 3745-27-09(C), you are hereby authorized to locate the Operating Record at the ARLI, 1585 Hardy Road, Akron, Ohio. The Operating Record shall be available to Ohio EPA upon request during regular business hours.

You are hereby notified that this action of the Director is final and may be appealed to the Environmental Review Appeals Commission (Commission) pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. The appeal must be accompanied by a filing fee of \$70.00 which the Commission, in its discretion, may reduce if by affidavit you demonstrate that payment of the full amount of the fee would cause extreme hardship. Notice of the filing of the appeal shall be filed with

the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section. An appeal may be filed with the Environmental Review Appeals Commission at the following address:
