

Dear Mr. Luebbe:

By document dated July 22, 1998, you submitted the Corrective Measures *Plan* to Ohio EPA's Central District Office for the Fayette County Landfill #3. The plan was submitted in accordance with Ohio Administrative Code (OAC) Rule 3745-27-10(F). Three revisions to the plan were subsequently submitted with the last one received on October 18, 2001.

Ohio EPA has reviewed the plan with all the revisions, and we have determined that the documents fulfill the requirements of OAC Rule 3745-27-10(F). Therefore, the selected corrective measure - Accelerated Landfill Cap Maintenance and Abandonment of Surface Impoundment - along with the corrective monitoring program are hereby approved.

You are hereby notified that this action of the Director of Environmental Protection is final and may be appealed to the Environmental Review Appeals Commission pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the ground upon which the appeal is based. It must be filed with the commission within 30 days after notice of the director's action, A copy of the appeal must be served on the director within three days of filing with the commission. An appeal may be filed with the commission at the following address:
